

**SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD  
1 July 2022 – 30 June 2023**

Pursuant to the Senate Order for entity contracts the following table sets out contracts entered into by the Tertiary Education Quality and Standards Agency (TEQSA) which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:

- (a) have not been fully performed as at 30 June 2023 or
- (b) have been entered into during the 12 months prior to 30 June 2023.
